

System Overview

The Stryker CORE Powered Instrument Driver (console) provides an integrated, centrally controlled environment that promotes safe and economical surgical practice.




Figure 1. System Block Diagram

The console's software provides control over system components including the console, the graphical user interface (GUI), the irrigation pump, and the connected handpieces and footswitches (see figure 1). The software's file management capability allows you to save and store user preference settings and have convenient access to a favorites list of the most frequently used files to improve efficiency.

The color display, with its touch sensitive screen, provides an intuitive graphical user interface that allows you to view multiple system components and set their parameters with the touch of a finger. Changes may be made rapidly, with little to no interruption during surgery.

Multiple handpieces and footswitches may be connected and operated simultaneously from a single console. Because options vary among different handpieces, the console will only display those options that are related to the connected handpiece.

An integral irrigation pump system reliably supplies coolant/irrigation to the cutting site with adjustable flow rates.

Various cutting accessories and irrigation cassettes used with the system are also recognized and identified on the console screen by means of a wireless tag technology.

Console settings, like display brightness and speaker volume, may be easily adjusted. The on board speaker provides audible feedback during operation and configuration.

The console accepts either 100 VAC - 230 VAC input and has the capability to power heavy-duty handpieces.

The Stryker Firewire Backbone (SFB) serial connection provides a serial communications channel between the console and other devices. This feature allows software upgrades over a computer network.




Figure 2. Console Hardware Features and Functions

To Connect the Components:




Figure 3. Console Interconnect Diagram

The console interconnect diagram provides the connection sequence of system components. The numbered call outs correspond to the numbered instructions on the next page. See the instructions for use supplied with each component for specific connection information. The illustrated hardware below provides a likeness, but may not be an exact representation of the actual hardware (see figure 3).

To Connect the Components (cont'd):

NOTE: See figures 2 and 3 while performing the instructions below. See the instructions for use supplied with each component for specific connection information.

- 1. Place the console on a sturdy, flat surface near a hospital-grade outlet.
- 2. Install the power cord plug into the power receptacle on the console.
- 3. Install the other end of the power cord into a hospital-grade wall outlet.
- 4. Press the power switch to turn the console on. See To Power Up and To Adjust Options sections for more information.

NOTES:

- The universal power supply will automatically adjust to match the voltage and frequency of the facility power.
- · As you connect components to the console, the console's screen will change to display the specific components that are connected.

CAUTIONS:

- · DO NOT thread or twist the push/pull connectors on the cords during installation or removal.
- When connecting or disconnecting a cable(s) to the front of the console, always hold the cable by its connector (the plug, not the cord). Failure to comply
 may result in damage to the cable or console.
- Cables that are connected to the front of the console have keyed, push-pull type connectors that lock into place. DO NOT force a connector into a console
 port. Each connector and port has an alignment mark to indicate proper cable orientation.
- 5. If using a footswitch, plug the footswitch cable into the console port marked with a FOOTSWITCH PORT symbol. Align the marks and gently push the connectors together. Two footswitches may be connected to the console.

NOTE: A registered wireless footswitch will be overridden and disabled when a wired footswitch is connected and registered to the same color footswitch port.

6. Plug the handpiece cord(s) into the console port(s) marked with a HANDPIECE PORT symbol. Align the marks and gently push the connectors together. Three handpieces may be connected to the console and two handpieces may be operated simultaneously.

NOTES:

- · If using a CORE Universal Handswitch, attach it to the handpiece before you plug the cord into the handpiece.
- If using CORE console software version 6.1 or later, a Heavy Duty Power Pack (power pack) may be used to allow either a Stryker System 4 or 5 Heavy Duty Handpiece to operate with the console. If a power pack is connected to the console, the associated heavy duty handpiece will take priority over other attached, inactive handpieces. Only one heavy duty handpiece may be operated using the power pack with the console. No other connected handpieces will be allowed to operate. See instructions for use supplied with the Heavy Duty Power Pack for connection information.
- 7. Plug the other end of the handpiece cord(s) into the handpiece(s). See instructions for use supplied with each handpiece for connection information.



WARNING: Use only Stryker approved cutting accessories.

8. Attach the cutting accessory to the handpieces. See the instructions for use supplied with each handpiece or attachment for cutting accessory installation information.

NOTE: If using the console irrigation pump (optional), install the Irrigation Pole REF 5100-050-028 (optional, may use equivalent irrigation pole) to the mounting bracket on the back of the console. Hang the irrigation bag from the pole.

- 9. If required, install the irrigation cassette into the console port marked with a IRRIGATION PUMP CASSETTE symbol.
- 10. If required, connect the irrigation tubing to the irrigation bag.
- 11. If required, attach the irrigation clips to the handpiece(s) and connect the tubing. Connect the irrigation tubing to the handpiece. See the instructions for use supplied with each handpiece for connection information.
- 12. Test all the system components to ensure that they are performing properly before surgery. Refer to the Button Definitions and Software Menu Map sections when using the graphical user interface.




Figure 5. Plug In Handpiece Cable Screen

Software Menu Navigation




Figure 6. Console Software Menu Map

The software menu map is a visual representation of how the software is structured and is designed to facilitate navigation (see figure 6). The map also provides the sequence of screen information provided in this manual, top down and left to right. The icons used in this map are button icons used in the software and also reside near header information in this manual. The screen illustrations used in this manual provide a likeness, but may not be an exact representation of the actual console screens.

To Select Settings:

The HOME screen is where most user interaction will take place (see figure 7). Up to three handpieces may be displayed on the screen simultaneously. When the console is initially turned on, the console settings are factory default settings until a user preference file is selected or the settings are manually modified.

NOTE: If the console screen is touched in two places simultaneously, unintended button activation may result.

Handpiece Operating Area

View and modify key handpiece settings.



View User Preference File Name

View name of file that contains handpiece settings for a specific procedure, for example, ACL (Anterior Cruciate Ligament) surgery.

Console Operating Area
Access key console functions.

Attached Handpieces

Three handpieces may be attached to the console and two may be operated simultaneously.

View Handpiece Name

View name of active handpiece. Three handpieces may be connected and displayed. Two powered handpieces may be operated from the same console, simultaneously.



View Option Settings

View option settings such as irrigation, footswitch control, and fixed or variable RPM (revolutions per minute). All of these settings may be modified.

View Cutting Accessory or Attachment Name

View cutting accessory or attachment name if the handpiece, accessory and/or attachment have been selected or have recognition capability.






To Adjust Handpiece Speed (or Power):


Figure 8. Home Screen - Speed (or Power)

From the HOME screen, touch the plus and minus buttons to adjust the handpiece speed or power set point in RPMs or percentage of power (see figure 8).

NOTE: When you install a cutting accessory with cutter recognition capability or select an attachment, the system will automatically override the selected speed setting in each mode to the speed settings that are appropriate for the installed cutting accessory.

While the handpiece is running, the display shows the actual handpiece speed. If the handpiece is not running, the default or selected speed is displayed.

The default speed is displayed for each handpiece until you adjust the speed set point based on the handpiece capability or modify the speed in a user preference file.



Touch the adjustment buttons (or slider bar that becomes visible when touching the speed value) to increase or decrease the speed (power) set point.

To Select Handpiece Mode and Direction:

From the HOME screen, touch the Select Direction/Mode button to adjust the handplece direction and mode (see figure 9).

NOTE: The available handpiece options, including handpiece direction and mode, will depend on the type of handpiece that is identified at the top of the screen.



FORWARD: Touch to cause the handpiece cutting accessory to rotate in the forward (clockwise) direction.

OSC: Touch to cause the handpiece cutting accessory to OSCillate.

HIGH: Touch to cause the handpiece to operate in the high RPM range mode.

To Adjust Options:

From the HOME screen, touch the Adjust Options button to adjust the handpiece options (buttons and trigger, such as handswitch). The available handpiece options will depend on the type of handpiece that is identified at the top of the screen (see figure 10).


NOTE: To program the footswitch pedals and pads, touch the Footswitch Options button.

Adjust Acceleration

- Touch the plus and minus buttons or slider bar to adjust the percent of acceleration [0 to 100%].
- At 100%, the handpiece speed accelerates quickly.
 Acceleration slows as the setting approaches zero percent.

Select Run Mode

- FIXED: handpiece runs at the full set speed or power. Varying pressure on the handswitch (or trigger) will not vary the handpiece speed or power.
- VARIABLE: handpiece speed responds to the degree of pressure applied to the handswitch (or trigger).
- ONE TOUCH: Handpiece activation responds to one touch of a trigger device (handswitch) and continues to run when the trigger device is released. Handpiece is deactivated by touching any trigger device. In this mode, the handpiece operates at constant set-point speed/power



Adjust Braking

- Touch the plus and minus buttons or slider bar to adjust the percent of braking [0 to 100%].
- At 100%, the handpiece stops abruptly. The amount of deceleration decreases as the setting approaches zero percent.

Adjust Oscillate Turns

- Touch the plus and minus buttons to select the number of turns per direction when running a handpiece in the oscillate mode.
- Touch the minus button until the TIME-BASED icon is visible to operate in a TIME-BASED mode where the number of turns are based on the speed of the handpiece.

To Program Footswitch Options:




Figure 11, Footswitch Options Screens

From the Adjust Options screen, touch the Program Footswitch button to program the footswitch pedals and pads based on the capabilities of the connected handpiece (see figure 11). Two footswitches may be connected to and simultaneously operated from the same console. However, two footswitches cannot be used to control the same handpiece at the same time.

NOTES:

- · Footswitch options will override individual handpiece settings unless the footswitch is programmed with default settings.
- · The following is a generic list of footswitch pedal and pad options that are available if the connected handpiece supports the option:

TPS Footswitch Pedals [A and/or B] and NSE Footswitch Pedal Options:

Direction:

- DEFAULT: will cause the handpiece to operate according to the HOME screen settings. These settings may be factory default settings of the connected handpiece or user programmed settings. Specific default settings vary based on how the handpiece was programmed at the factory or Home screen.
- FORWARD [FWD]: pressure on the pedal will cause the handpiece to rotate in the forward (clockwise) direction.
- REVERSE [REV]: pressure on the pedal will cause the handpiece to rotate in the reverse (counterclockwise) direction.
- . DISABLE: will disable the footswitch pedal.

Operating Mode:

- DEFAULT: will cause the handpiece to operate according to the factory default setting of the connected handpiece. Specific default settings vary based on how the handpiece was programmed at the factory.
- HIGH: pressure on the footswitch pedal will cause the handpiece to operate in the high-speed range or mode.
- LOW: pressure on the footswitch pedal will cause the handpiece to operate in the low speed range or mode.
- OSC: pressure on the footswitch pedal will cause the handpiece to OSCillate.

Run Mode:

- DEFAULT: will cause the handpiece to operate according to the factory default setting of the connected handpiece. Specific default settings vary based on how the handpiece was programmed at the factory (DEFAULT will cause the handpiece to operate in the specific RUN mode selected in the Adjust Options screen).
- VARIABLE: varying pressure on the footswitch pedal will cause the handpiece speed to vary.
- FIXED: pressure on the footswitch pedal will cause the handpiece to operate at a constant speed as set on the HOME screen.
- 1 TOUCH: acting like an on/off toggle, tap the footswitch pedal to operate the handpiece at the maximum speed. Tap the footswitch pedal again to stop the operation.

Footswitch Pads [I, II, and/or III] Options:

NOTE: The IRRIGATION ON/OFF and FWD<>REV stand-alone buttons on the NSE Footswitch can not be programmed to any footswitch pad options other than DISABLE.

- SPEED INCREMENT [INC]: pressure on the pad will increment the set point speed.
- SPEED DECREMENT [DEC]: pressure on the pad will decrement the set point speed.
- IRRIGATION INCREMENT [INC]: pressure on the footswitch pad will
 increment the pump flow set point and increase irrigation to the handpiece
 cutting accessory.
- IRRIGATION DECREMENT [DEC]: pressure on the footswitch pad will decrement the pump flow set point and decrease irrigation to the handpiece cutting accessory.
- IRRIGATION ON/OFF: pressure on the footswitch pad will toggle the irrigation pump on and off.
- OSC<>HIGH/LOW: pressure on the pad will toggle the operating mode of the handpiece.
- HIGH<>LOW: pressure on the pad will toggle the operating mode of the handpiece speed.
- FWD<>REV: pressure on the pad will toggle the direction of handpiece rotation
- CHANGE PORT: pressure on the footswitch pad will change the footswitch assignment to another assigned handpiece.
- FLUSH: pressure on the pad will turn the irrigation pump on at the flush rate [300%].
- CHANGE ATTACHMENT: pressure on the footswitch pad will toggle through the list of attachments that are available for the handpiece. Available attachments are handpiece dependent.
- DISABLE: will disable the footswitch pad.
- JOG: pressure on the footswitch pad will cause the cutting accessory to rotate at a very low speed to position the cutting edge within the cutting window.



To Program Footswitch Options: (cont'd)



WARNING: When a footswitch is connected or disconnected from the console, the handpiece to footswitch assignment will change. Verify the handpiece to footswitch assignment is correct before using a handpiece in a procedure. Failure to comply may result in patient and/or operating room staff injury.

Assign Footswitch to Handpiece Port

The Assign Footswitch to Handpiece screen will appear automatically when connecting two footswitches and two or more handpieces to the console (see figure 12). This screen will also appear when a footswitch is plugged into an unassigned footswitch port.

To Set Handpiece Options:



WARNING: Read and understand the appropriate Stryker handpiece instructions for use.




Figure 14. Set Handpiece Options Screen

From the Adjust Options screen, touch the Set Handpiece Options button to select specific handpiece options and assign them to a particular handpiece button (see figure 14). 

To Set Advanced Handpiece Options:

Set Handswitch Control Button

Press the button to toggle the handswitch control function to ON or OFF.



Adjust Torque Control Setting







Figure 17. Swap (replace) User Preference Favorite Pop-up



Figure 19. Select User Preference Favorite - File




To Adjust Irrigation Pump Settings:

NOTE: If using the irrigation pump, assemble the irrigation pole to the mounting bracket located on the back of the console. Hang the irrigation bag from the pole. Install the irrigation cassette into the console pump. Attach the irrigation clips onto the handpiece and connect the tubing.

From the HOME screen, touch the Adjust Irrigation Pump Settings button to adjust and apply an irrigation flow rate to a handpiece cutting accessory (see figure 20). AUTO PRIME and FLUSH options are also provided.

Adjust Irrigation % Setting

- Touch the slide bar or plus/minus buttons to adjust the flow rate percentage of irrigation [0 to 100%] to the cutting accessory of the handpiece.
- At 100%, irrigation to the handpiece is set to maximum flow rate. The rate decreases as the setting approaches zero.



AUTO PRIME Tubing Set

- Touch to activate the priming sequence of the installed irrigation cassette.
- The tubing will be primed from the pump head to the irrigation tip.

FLUSH Tubing Set - Touch and hold to provide a continuous flow rate of 300 mL/min with no irrigation clip and a minimum pressure of 30 psi when the tubing is blocked.

Select Handpiece

- Touch one or all of the handpiece buttons to allow activation of the irrigation pump. If no buttons are selected, the pump will not
 operate.
- · Activation will apply an irrigation flow rate to the handpiece cutting accessory.
- The flow rate will depend on the type of handpiece.
- Activating a handpiece will gain control of the console irrigation. While the first activated handpiece is running, activating another
 handpiece will not change pump flow, but may reduce irrigation to the first handpiece if a dual disposable irrigation cassette REF 5400050-002 is used. To gain complete control of console irrigation, stop the first handpiece and activate the other handpiece.




Figure 21. Adjust Console Options Screen - Standard User Mode




Figure 22. Access Advance User Mode Pop-up




Figure 23. Adjust Console Options Screen - Advanced User Mode




Figure 24. Return to Standard User Mode Pop-up










Figure 29. Manage User Preferences Screen - Files











Figure 31. Modify File Screen




Figure 33. View Handpiece Settings Screen




Figure 34. Typical Edit Setting Screen


